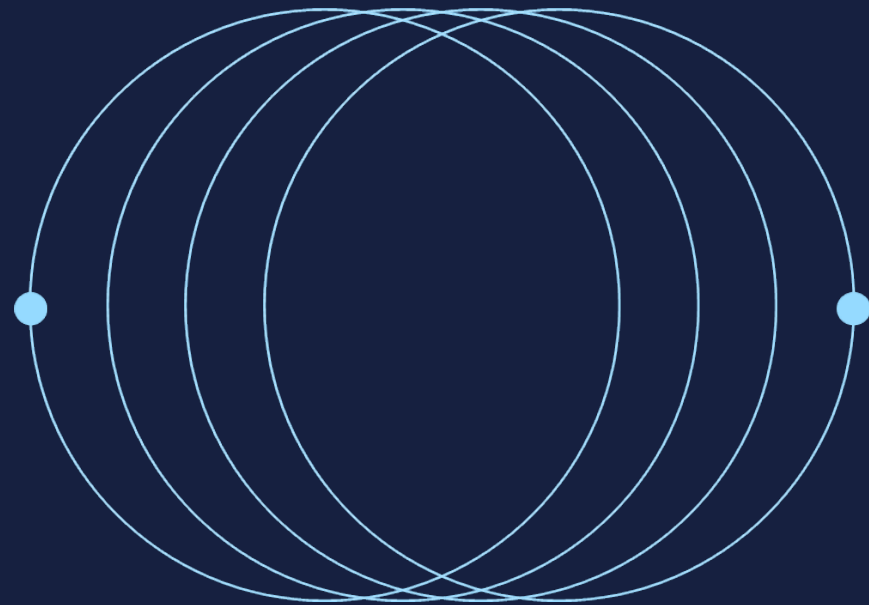

WASHINGTON, D.C. AND NEW YORK, NY – AUGUST 5, 2026 – The Carlyle Group Inc. (NASDAQ: CG) today reported its unaudited results for the second quarter ended June 30, 2026.

U.S. GAAP RESULTS

U.S. GAAP results for Q2 2026 included income before provision for income taxes of \$274 million and a margin on income before provision for income taxes of 24.4%.

DIVIDEND

The Board of Directors has declared a quarterly dividend of \$0.35 per common share to holders of record at the close of business on August 17, 2026, payable on August 26, 2026.

• Fund management fees increased in 2Q'26 compared to 2Q'25, driven by capital markets and transaction fees earned in connection with several large deals in our Global Private Equity segment. This increase was partially offset by a \$13 million decrease in catch-up fund management fees from \$24 million to \$11 million. Fund management fees in 2Q'25 also included \$19 million of catch-up subordinated management fees from our aviation funds.

• Investment income, including performance allocations, in 2Q'26 primarily reflected unrealized performance allocations in our credit opportunities and aviation strategies in Global Credit, our secondaries & portfolio finance strategy in Carlyle Alpinvest, and our international energy strategy in Global Private Equity, partially offset by the reversal of unrealized performance allocations in our seventh U.S. Buyout fund.

• Equity-based compensation increased in 2Q'26 compared to 2Q'25, primarily driven by stock awards granted in December 2025 and February 2026 to further align leadership with Company performance.

• Net investment income of Consolidated Funds in 2Q'26 included unrealized investment losses of approximately \$47 million related to an investment in a consolidated infrastructure fund in Global Private Equity. Through June 30, 2026, the cumulative unrealized investment loss recognized with respect to this investment attributable to the Company was approximately \$222 million, which will be realized upon the disposition of the fund's investment, which the Company currently expects will occur later in 2026.

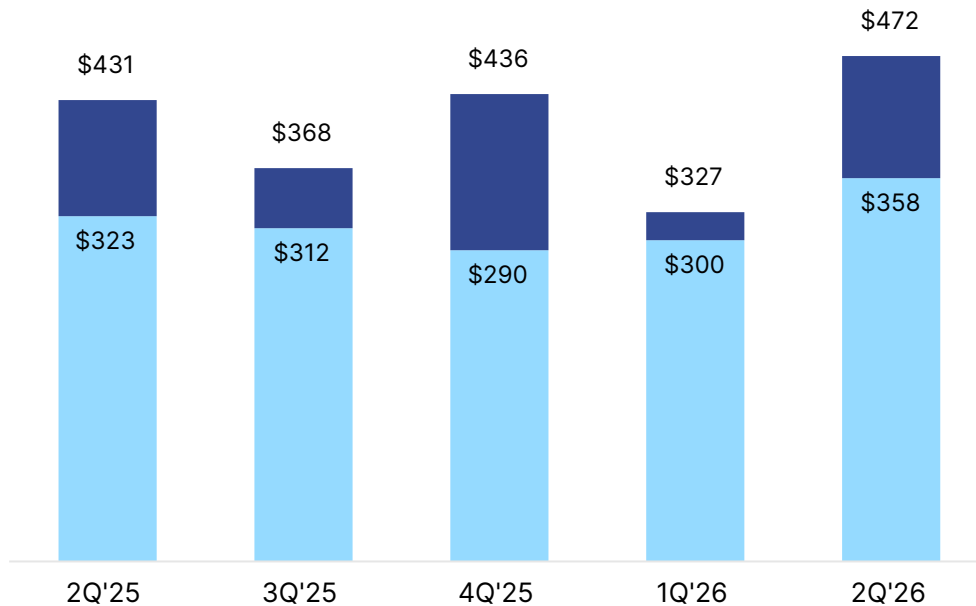

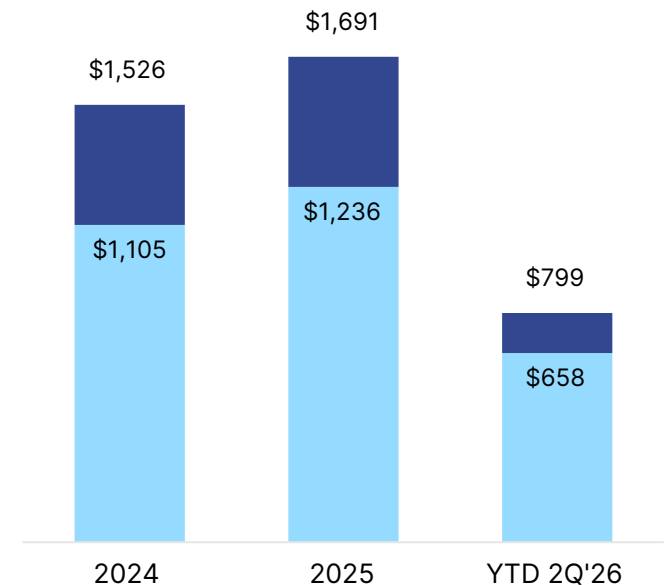
QUARTERLY DISTRIBUTABLE EARNINGS

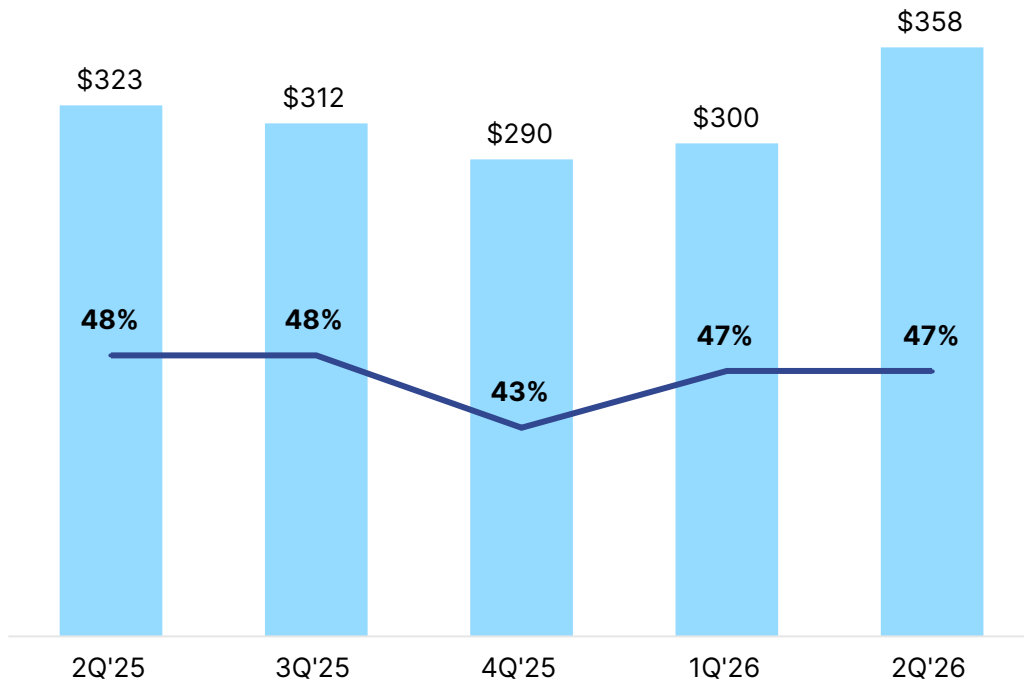

Fee Related Earnings

- **Fee Related Earnings** of \$358 million in Q2 2026 increased 11% compared to \$323 million in Q2 2025. Fee Related Earnings of \$658 million YTD increased by 4% from \$634 million in the prior YTD period
- **FRE margin²** of 47% in Q2 2026 decreased from 48% in Q2 2025. FRE margin was 47% YTD

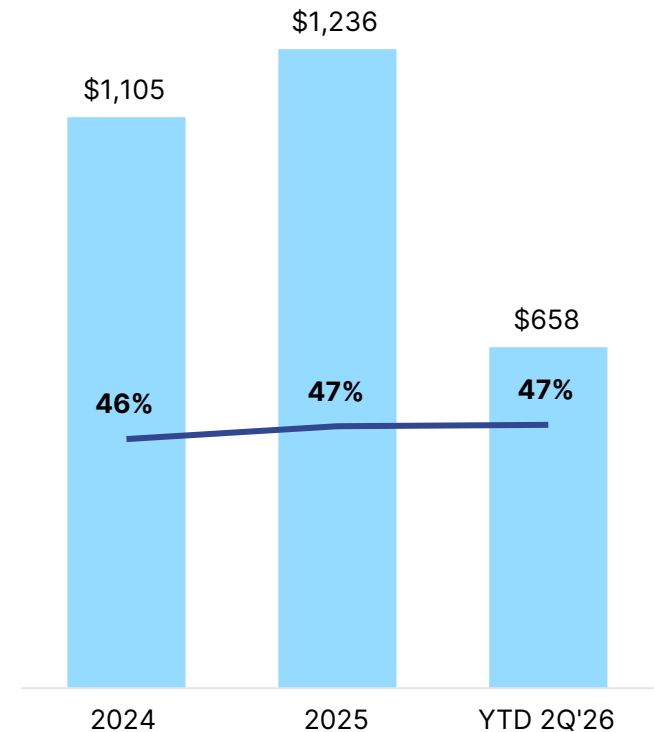
QUARTERLY FRE AND FRE MARGIN

dollars in millions



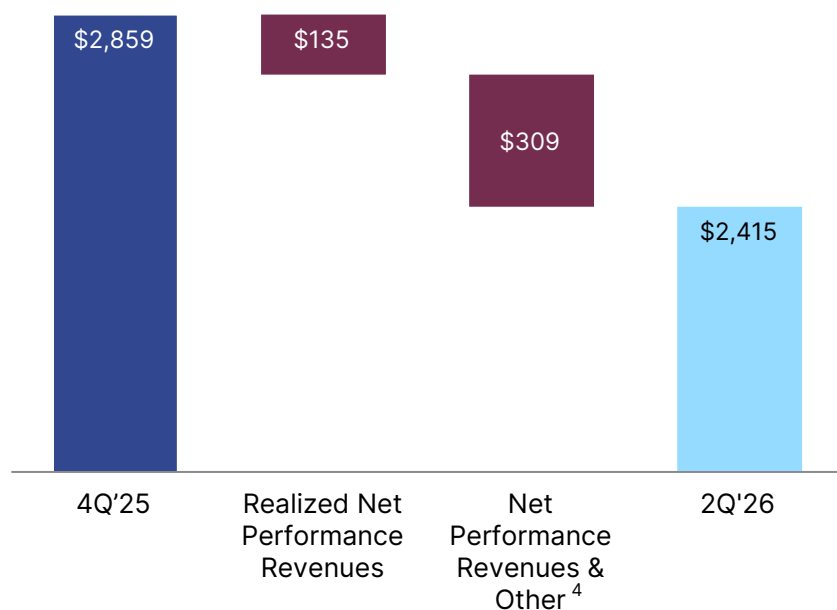

Performance Revenues

- **Net Accrued Performance Revenues³** were \$2.4 billion as of Q2 2026, down 7% from the prior quarter, primarily driven by carry realizations during the quarter and lower net accrued carry in our seventh U.S. buyout fund, partially offset by the impact of appreciation in our international energy funds
- **Realized Net Performance Revenues** were \$115 million in Q2 2026, driven by our fourth Japan buyout fund, which realized carry for the first time in Q2 2026, our sixth U.S. buyout fund, and our second credit opportunities fund

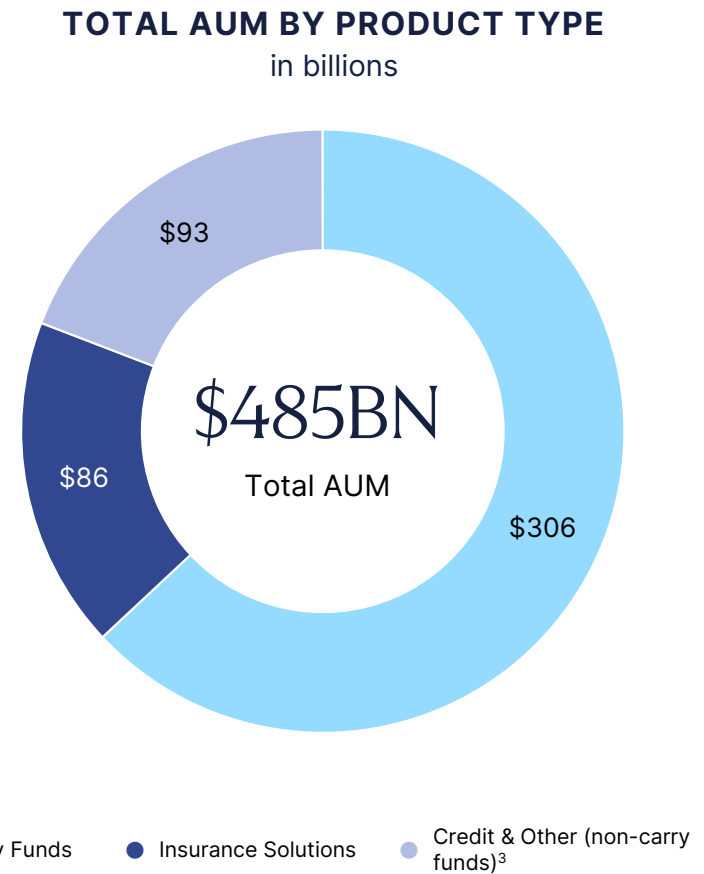
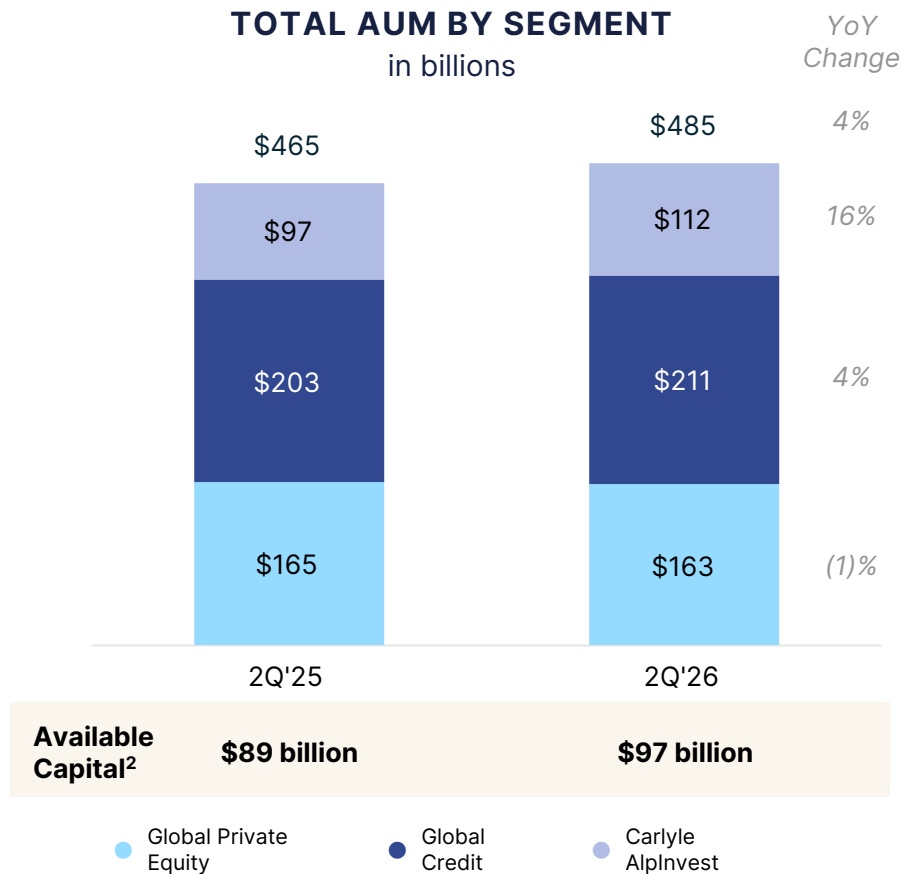

Total Assets Under Management

Total Assets Under Management¹ of \$485 billion at June 30, 2026 increased 2% from the prior quarter as Global Private Equity AUM increased 2%, Carlyle Alpinvest AUM increased 4%, and Global Credit AUM increased 1%. Total Assets Under Management was up 4% from one year ago, driven by a 16% increase in Carlyle Alpinvest AUM and a 4% increase in Global Credit AUM, partially offset by a 1% decline in Global Private Equity AUM

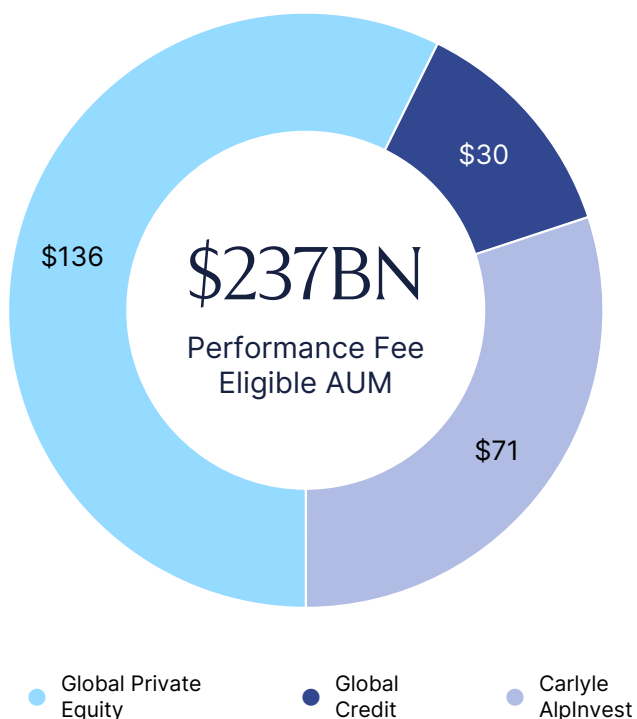

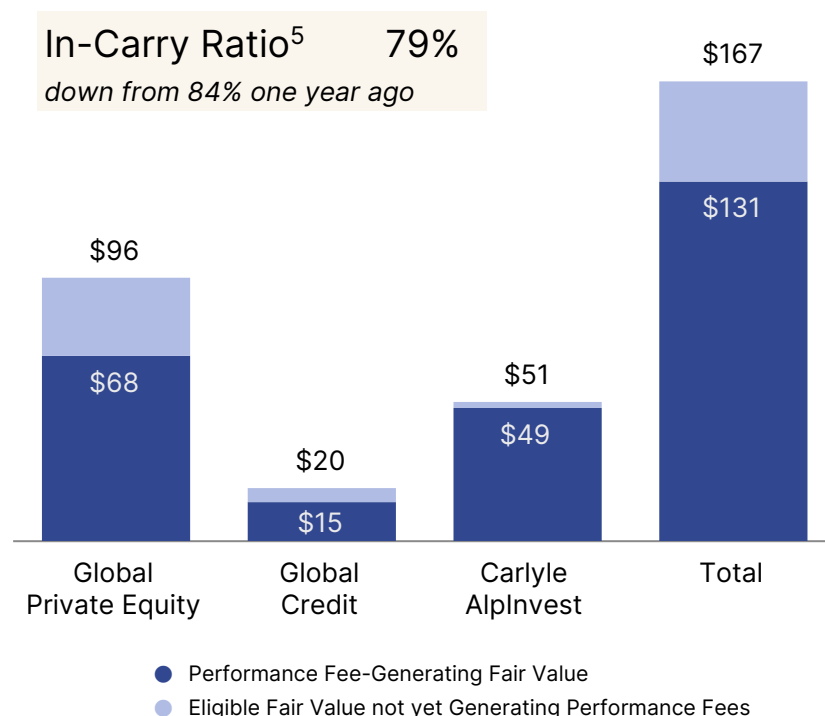
Performance Fee Eligible Assets Under Management

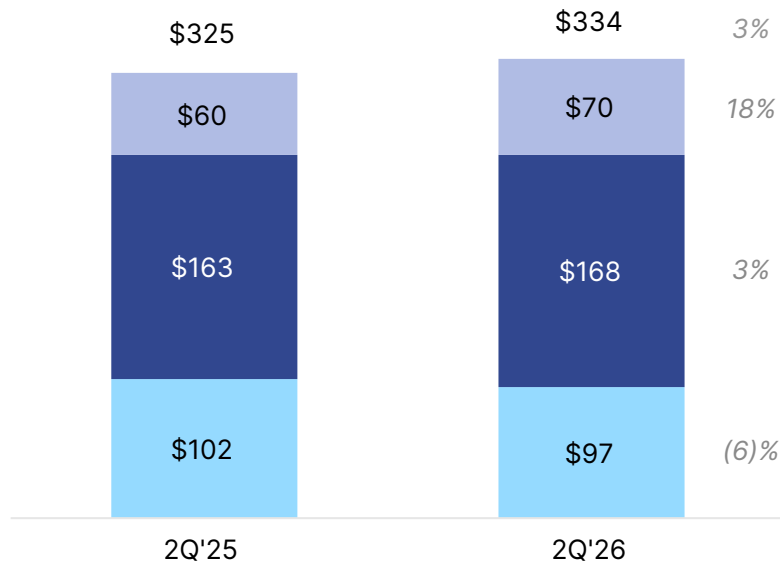
Fee-earning Assets Under Management

Fee-earning Assets Under Management⁶ of \$334 billion at June 30, 2026 increased slightly from the prior quarter, as a 3% increase in Carlyle Alpinvest and 1% increase in Global Credit were offset by a 3% decrease in Global Private Equity. Fee-earning Assets Under Management were up 3% from one year ago. **Pending FEAUM** of \$28 billion increased from \$21 billion in the prior quarter

Pending FEAUM⁷

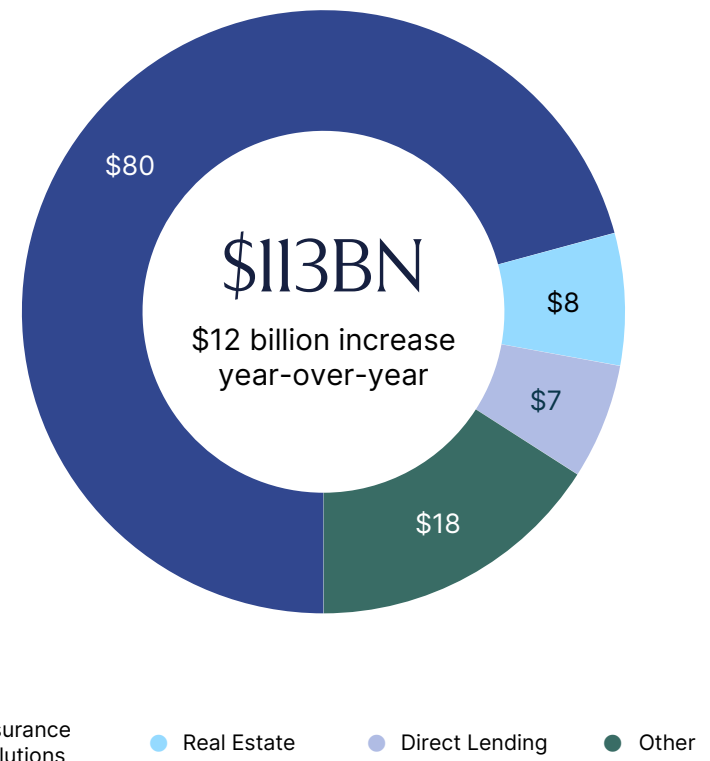

Key Metrics Activity

- **Inflows**¹ were \$16.8 billion in Q2 2026, driven by activity across all segments, including \$5 billion of commitments earmarked for the next vintage U.S. buyout fund in our Global Private Equity segment, continued momentum in our Carlyle AlInvest secondaries & portfolio finance strategy, as well as the closing of three new-issue U.S. CLOs and reinsurance activity in our Global Credit segment. Inflows of \$55.8 billion for the LTM increased 10% compared to the prior LTM period
- **Deployment**² was \$14.3 billion in Q2 2026, led by activity across our Global Credit segment, notably in our U.S. liquid credit, direct lending, and opportunistic credit strategies, and our Global Private Equity segment, driven by purchases in our U.S. buyout funds. Deployment of \$53.0 billion for the LTM increased 4% compared to the prior LTM period
- **Realized Proceeds** from carry funds were \$6.7 billion in Q2 2026, driven by realizations in our Japan and U.S. buyout funds and activity across our Carlyle AlInvest segment. Realized Proceeds of \$36.8 billion for the LTM increased 12% compared to the prior LTM period
- **Carry Fund Appreciation** was 3% in Q2 2026 and 7% for the LTM

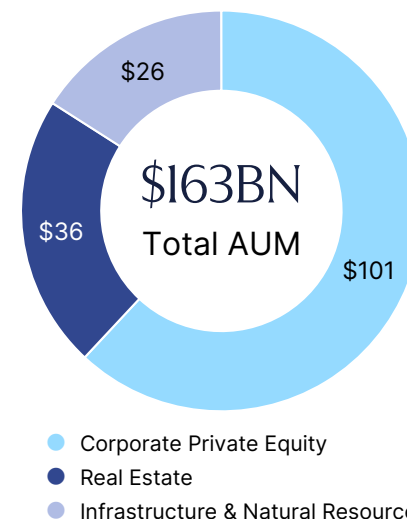
Segment Highlights

Global Private Equity

- **Total AUM** was \$163 billion as of June 30, 2026, up 2% from the prior quarter, as **Inflows** of \$6.4 billion and 2% appreciation more than offset realizations in Q2 2026. Inflows in Q2 2026 included \$5 billion of commitments earmarked for our next vintage U.S. buyout fund. Total AUM decreased 1% from the prior year, driven by LTM realizations of \$20.1 billion
- **Deployment** was \$4.0 billion in Q2 2026 and \$10.3 billion for the LTM. Notable Q2 2026 transactions included Surventis (CP VIII / CAP VI) and MAI Capital (CP VIII)
- **Realized Proceeds** totaled \$3.9 billion in Q2 2026 and \$20.1 billion for the LTM. Notable Q2 2026 transactions included Vantage Group Holdings (CP VII / CGFSP III), Rigaku Corporation (CJP IV), and Iwasaki Electric Co. (CJP IV)

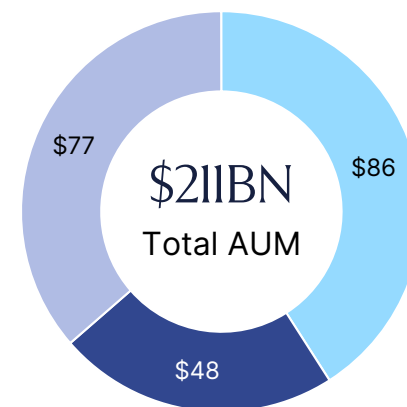

Global Credit

- **Total AUM** was \$211 billion as of June 30, 2026, up 1% from the prior quarter, as **Inflows** of \$5.8 billion and market activity more than offset outflows. Inflows in Q2 2026 were driven by our U.S. liquid credit and insurance solutions strategies. Total AUM increased 4% from one year ago, including \$25.0 billion of Inflows in the LTM
- **Deployment** was \$7.1 billion in Q2 2026 and \$27.6 billion for the LTM. Q2 2026 activity was driven by our U.S. liquid credit, direct lending, and opportunistic credit strategies, including a follow-on investment in Content Partners
- **Realized Proceeds** in traditional carry funds totaled \$1.3 billion in Q2 2026 and \$6.0 billion for the LTM
- **Fund management fees** were \$149 million in Q2 2026 and \$296 million YTD. Prior year periods included approximately \$19 million of catch-up subordinated management fees from our aviation strategy

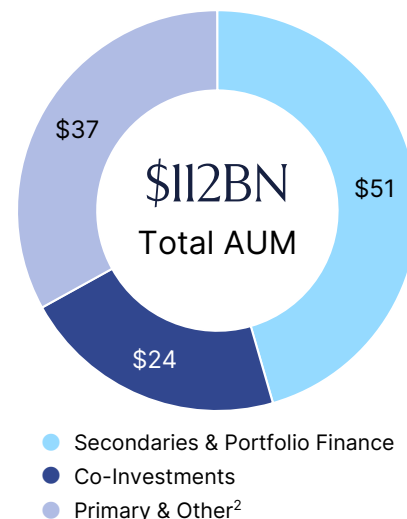

Carlyle AlInvest

- **Total AUM** was \$112 billion as of June 30, 2026, a 4% increase from the prior quarter, as **Inflows** of \$4.5 billion and 3% appreciation exceeded outflows in Q2 2026. Inflows in Q2 2026 reflected fundraising across the segment, notably in our secondaries & portfolio finance and CAPM funds. Total AUM increased 16% from one year ago, including LTM Inflows of \$20.2 billion
- **Deployment** was \$3.2 billion in Q2 2026 and \$15.1 billion for the LTM. Deployment in Q2 2026 was driven primarily by our secondaries & portfolio finance, CAPM, and CAPS funds
- **Realized Proceeds** totaled \$1.6 billion in Q2 2026 and \$10.7 billion for the LTM
- **Net Accrued Performance Revenues** reached \$655 million as of Q2 2026, a 4% increase from \$627 million as of Q2 2025

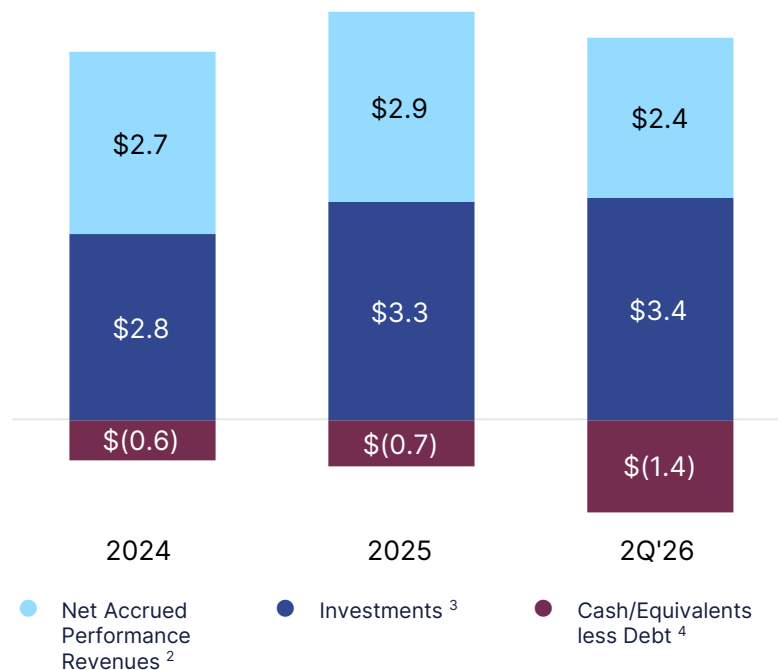

DIVIDEND POLICY

Our dividend policy for our common stock is an annual rate of \$1.40 per share (\$0.35 per common share on a quarterly basis). The declaration and payment of any dividends to holders of our common stock are subject to the discretion of our Board of Directors, which may change our dividend policy at any time or from time to time, and the terms of our amended and restated certificate of incorporation. There can be no assurance that dividends will be made as intended or at all or that any particular dividend policy will be maintained.

NON-GAAP FINANCIAL MEASURES

This press release contains financial measures that are calculated and presented on the basis of methodologies other than in accordance with generally accepted accounting principles in the United States. These non-GAAP financial measures should be considered in addition to and not as a substitute for, or superior to, financial measures presented in accordance with U.S. GAAP. The reasons management believes that these non-GAAP financial measures provide useful information are set forth in our most recent Annual Report on Form 10-K filed with the SEC.

NOTES ON CARLYLE CONSOLIDATED GAAP RESULTS (PAGE 5)

1. Income (loss) before provision for income taxes is the GAAP measure that is most directly comparable to Distributable Earnings, which management uses to measure the performance of the business. A full reconciliation is included starting on page 29.
2. Margin on income (loss) before provision for income taxes is equal to Income (loss) before provision for income taxes, divided by Total revenues.
3. Net performance revenues are equal to Performance revenues less Performance revenues related compensation expense.

NOTE ON TOTAL SEGMENT RESULTS (PAGES 7-10)

Adjustments to principal investment income (loss) also include the reclassification of earnings for the investments in NGP Management and its affiliates to the appropriate operating captions for the segment results, the exclusion of charges associated with the investment in NGP Management and its affiliates that are excluded from the segment results and the exclusion of the principal investment loss from the dilution of the indirect investment in Fortitude.
